# **About the Safeguard product line**

The Safeguard for Privileged Passwords 3000 and 2000 Appliances are built specifically for use only with the Safeguard for Privileged Passwords privileged management software, which is pre-installed and ready for immediate use. The appliance is hardened to ensure the system is secured at the hardware, operating system, and software levels. The hardened appliance approach protects the privileged management software from attacks while simplifying deployment and ongoing management and shortening the time frame to value.

Safeguard for Privileged Passwords virtual appliances and cloud applications are also available. When setting up a virtual environment, carefully consider the configuration aspects such as CPU, memory availability, I/O subsystem, and network infrastructure to ensure the virtual layer has the necessary resources available. See One Identity's Product Support Policies for more information on environment virtualization.

#### Safeguard privileged management software suite

Safeguard privileged management software is used to control, monitor, and govern privileged user accounts and activities to identify possible malicious activities, detect entitlement risks, and provide tamper proof evidence. The Safeguard products also aid incident investigation, forensics work, and compliance efforts.

The Safeguard products' unique strengths are:

- One-stop solution for all privileged access management needs
- Easy to deploy and integrate
- Unparalleled depth of recording
- Comprehensive risk analysis of entitlements and activities
- Thorough Governance for privileged account

The suite includes the following modules:

- Safeguard for Privileged Passwords automates, controls, and secures the
  process of granting privileged credentials with role-based access management and
  automated workflows. Deployed on a hardened appliance, Safeguard for Privileged
  Passwords eliminates concerns about secured access to the solution itself, which
  helps to speed integration with your systems and IT strategies. Plus, its usercentered design means a small learning curve and the ability to manage passwords
  from anywhere and using nearly any device. The result is a solution that secures your
  enterprise and enables your privileged users with a new level of freedom and
  functionality.
- One Identity for Privileged Sessions is part of One Identity's Privileged Access
  Management portfolio. Addressing large enterprise needs, Safeguard for Privileged
  Sessions is a privileged session management solution, which provides industryleading access control, as well as session monitoring and recording to prevent
  privileged account misuse, facilitate compliance, and accelerate forensics
  investigations.
  - Safeguard for Privileged Sessions is a quickly deployable enterprise appliance, completely independent from clients and servers to integrate seamlessly into existing networks. It captures the activity data necessary for user profiling and enables full user session drill-down for forensics investigations.
- One Identity Safeguard for Privileged Analytics integrates data from Safeguard for Privileged Sessions to use as the basis of privileged user behavior analysis. Safeguard for Privileged Analytics uses machine learning algorithms to scrutinize behavioral characteristics, and generates user behavior profiles for each individual privileged user. Safeguard for Privileged Analytics compares actual user activity to user profiles in real time, and profiles are continually adjusted using



machine learning. Safeguard for Privileged Analytics detects anomalies and ranks them based on risk so you can prioritize and take appropriate action and ultimately prevent data breaches.

# **New features**

## New license required (285833)

All customers upgrading to Safeguard for Privileged Passwords 7.0 require a new license. For more information, see <a href="https://support.oneidentity.com/contact-us/licensing">https://support.oneidentity.com/contact-us/licensing</a>. Once the new license is installed, Appliance Administrators will need to read and accept the Software Transaction Agreement before Safeguard for Privileged Passwords will be fully functional.

# Changes to the secure VPN (284017)

Changes have been made to the secure VPN that protects communication between appliances in a clustered high-availability configuration. The new VPN only supports the UDP 655 port. Before upgrading, ensure the firewall configurations between appliances permit UDP 655.

# v4 API now available (294662)

The v4 API is now available for use alongside the v3 API.



## Web client updates

Starting with Safeguard for Privileged Passwords 7.0, only the web client is available. A number of features previously only found in the desktop client have been added to the web client.

- Activity Center added (284020): The Activity Center has been added to the web client with an updated look and feel to improve your web client experience.
- Reasons, Custom Platforms, and Registered Connectors added (298940):
  - Reasons: This page has been added to Security Policy Management |
     Settings. It allows for managing the reasons for requesting access to a
     password, SSH key, or session.
  - Connect and Platforms: This page has been added to Asset Management.
     It allows for managing the registered connectors (once joined to One Identity Starling) and custom platforms that have been configured for Safeguard for Privileged Passwords.
- Entitlement and Ownership reports added (301855): You can now export entitlement and ownership reports in .csv or .json formats.
- Desktop client Dashboard functionalities added (301435): Access Request Activity and Account Automation pages have been added to the web client.

#### **Application Auto-Login Session recordings (284362)**

Using Safeguard for Privileged Sessions's RemoteApp launcher, you can now launch a remote desktop application session from within Safeguard for Privileged Passwords which only records the selected application rather than the entire windows server.

# Accounts and assets now indicate whether the password profile and/or SSH key profile were inherited (300048)

When viewing assets and accounts in the web client, the **Management** properties section of the **Properties** tab indicates if the password profile and/or SSH key profile were inherited from the asset or partition, or set explicitly for the asset or account. When a profile has been explicitly set for the asset or account, you also have the ability to clear the set profile.

# **Application switcher now available (284024)**

A new option has been added to the web client which allows users to easily navigate to One Identity products related to Safeguard for Privileged Passwords. This new feature includes links to the following products:



- Safeguard for Privileged Sessions (only appears when linked to Safeguard for Privileged Passwords)
- Starling Remote Access
- Starling Connect
- Starling Cloud Assistant

## Data export capabilities (234914)

Throughout the web client, an **Export** button now appears above a table to indicate when the data in the table can be exported as either a JSON or CSV file.

## **Email Events page added (304109)**

A new **Email Events** page has been added to **Appliance Management** | **External Integration**. This page is used for adding and managing the subscribers that receive emails for specific Safeguard for Privileged Passwords events.

## **OneLogin multi-factor authentication support (295669)**

Appliance administrators can now configure Safeguard for Privileged Passwords to integrate with OneLogin MFA in order to allow for secure user logins. For information on OneLogin, see OneLogin documentation.

# **Deprecated features**

- Desktop client is no longer available starting with 7.0. Only the web client is supported.
- Changes have been made to the secure VPN that protects communication between appliances in a clustered high-availability configuration. The new VPN only supports the UDP 655 port. Before upgrading, ensure the firewall configurations between appliances permit UDP 655.
- Approval Anywhere and Starling Two-Factor Authentication functionalities have been deprecated. Any Safeguard for Privileged Passwords customers currently using Starling Two-Factor Authentication as their authentication provider should wait to upgrade until they have removed all Starling Two-Factor Authentication related user information.

# **Known issues**

The following is a list of issues known to exist at the time of release.

#### **Known issue**

Issues may occur when launching telnet sessions after upgrading a Safeguard for Privileged Sessions appliance. If you are experiencing issues, ensure you have downloaded and installed the latest telnet plugin before contacting support. Additional information on configuring and supporting tenet sessions is also available on the telnet plugin site.

If session playback is failing for fully indexed sessions, the desktop player may need to be upgraded to 1.9.4 or greater.

SPS initiated sessions failing when using netbios name.

Workaround: Use the domain name.

For Linux-based platforms, if an account password is encrypted with an algorithm that is

not supported by Safeguard, then the CheckPassword operation falls back to validating the password by attempting to login as the account. The following algorithms are supported:

BCrypt, LDAP, MD5, PHPass, SHA256, SHA512, Traditional and Extended DES. Blowfish, SCrypt, and PBKDF2 for any HMAC.

# System requirements and versions

Safeguard for Privileged Passwords allows you to manage access requests, approvals, and reviews for your managed accounts and systems.

- The web client consists of an end-user view and administrator view. The fully featured client exposes all of the functionality of Safeguard based on the role of the authenticated user.
- The web management console displays whenever you connect to the virtual appliance and is used for first time configuration.
   When setting up a virtual environment, carefully consider the configuration aspects such as CPU, memory availability, I/O subsystem, and network infrastructure to ensure the virtual layer has the necessary resources available. See One Identity's Product Support Policies for more information on environment virtualization.

Ensure that your system meets the minimum hardware and software requirements for these clients.

If a Safeguard Sessions Appliance is linked to Safeguard for Privileged Passwords, session recording is handled via Safeguard for Privileged Session. The link is initiated from Safeguard for Privileged Sessions. For details about the link steps and issue resolution, see the *One Identity Safeguard for Privileged Sessions Administration Guide*.

#### **Bandwidth**

It is recommended that connection, including overhead, is faster than 10 megabits per second inter-site bandwidth with a one-way latency of less than 500 milliseconds. If you are using traffic shaping, you must allow sufficient bandwidth and priority to port 655 UDP in the shaping profile. These numbers are offered as a guideline only in that other factors could require additional network tuning. These factors include but are not limited to: jitter, packet loss, response time, usage, and network saturation. If there are any further questions, please check with your Network Administration team.

#### Platforms and versions follow.

- You must license the VM with a Microsoft Windows license. We recommend using either the MAK or KMS method. Specific questions about licensing should be directed to your Sales Representative.
- Supported hypervisors:
  - Microsoft Hyper-V (VHDX) version 8 or higher
  - VMware vSphere with vSphere Hypervisor (ESXi) versions 6.5 or higher
  - VMware Worksation version 13 or higher



 Minimum resources: 4 CPUs, 10GB RAM, and a 500GB disk. The virtual appliances default deploy does not provide adequate resources. Ensure these minimum resources are met.

# Supported platforms

Safeguard for Privileged Passwords supports a variety of platforms, including custom platforms.

#### **Safeguard for Privileged Passwords tested platforms**

The following table lists the platforms and versions that have been tested for Safeguard for Privileged Passwords (SPP). Additional assets may be added to Safeguard for Privileged Passwords. If you do not see a particular platform listed when adding an asset, use the **Other, Other Managed, Other Directory**, or **Linux** selection on the **Management** tab of the **Asset** dialog.

#### **SPP linked to SPS: Sessions platforms**

CAUTION: When linking your One Identity Safeguard for Privileged Sessions (SPS) deployment to your One Identity Safeguard for Privileged Passwords (SPP) deployment, ensure that the SPS and SPP versions match exactly, and keep the versions synchronized during an upgrade. For example, you can only link SPS version 6.6 to SPP version 6.6, and if you upgrade SPS to version 6.7, you must also upgrade SPP to 6.7.

Make sure that you do not mix Long Term Supported (LTS) and feature releases. For example, do not link an SPS version 6.0.1 to an SPP version 6.1.

When Safeguard for Privileged Passwords (SPP) is linked with a Safeguard for Privileged Sessions (SPS) appliance, platforms are supported that use one of these protocols:

• SPP 2.8 or lower: RDP, SSH

• SPP 2.9 or higher: RDP, SSH, or Telnet

Some platforms may support more than one protocol. For example, a Linux (or Linux variation) platform supports both SSH and Telnet protocols.

Safeguard for Privileged Passwords checks to ensure the values match the type of the property that include a string, boolean, integer, or password (which is called secret in the API scripts). Safeguard for Privileged Passwords cannot check the validity or system impact of values entered for custom platforms.

# Long Term Support (LTS) and Feature Releases

Releases use the following version designations:

- Long Term Support (LTS) Releases: The first digit identifies the release and the second is a zero (for example, 6.0 LTS).
- Maintenance LTS Releases: A third digit is added followed by LTS (for example, 6.0.6 LTS).
- Feature Releases: The Feature Releases version numbers are two digits (for example, 6.6).

Customers choose between two paths for receiving releases: Long Term Support (LTS) Release or Feature Release. See the following table for details.

**CAUTION:** Downgrading from the latest Feature Release, even to an LTS release, voids support for SPP.

One Identity strongly recommends always installing the latest revision of the release path you use (Long Term Support path or Feature Release path).

#### **Moving between LTS and Feature Release versions**

You can move from an LTS version (for example, 6.0.7 LTS) to the same feature version (6.7) and then patch to a later feature version. After that, you can patch from the minimum version for the patch, typically N-3. If you move from an LTS version to a feature version, you will receive a warning like the following which informs you that you will only be able to apply a Feature Release until the next LTS Release:

Warning: You are patching to a Feature Release from an LTS Release. If you apply this update, you will not be able to upgrade to a non-Feature Release until the next LTS major release version is available. See the Administration Guide for details.

You cannot move from a Feature Release to LTS Release. For example, you cannot move from 6.7 to 6.0.7 LTS. You have to keep upgrading with each new Feature Release until the next LTS Release version is published. For this example, you would wait until 7.0 LTS is available.

#### **Patching**

You can only patch from a major version. For example, if you have version 6.6 and want to patch to 7.7, you must patch to 7.0 LTS and then apply 7.7.

An LTS major version of Safeguard for Privileged Passwords (SPP) will only work with the same LTS major version of Safeguard for Privileged Sessions (SPS). For the best experience, it is recommended you use the latest supported version.

It comes hardened to ensure the system is secure at the hardware, operating system, and software levels.

# **Appliance LCD and controls**

The front panel of the Safeguard for Privileged Passwords 3000 Appliance and 2000 Appliance contain the following controls for powering on, powering off, and scrolling through the LCD display.

- Green check mark button: Use the **Green check mark** button to start the appliance. Press the **Green check mark** button for NO more than one second to power on the appliance.
  - ▲ CAUTION: Once the Safeguard for Privileged Passwords Appliance is booted, DO NOT press and hold the Green check mark button. Holding this button for four or more seconds will cold reset the power of the appliance and may result in damage.
- Red X button: Use the Red X button to shut down the appliance. Press and hold the Red X button for four seconds until the LCD displays POWER OFF.
  - CAUTION: Once the Safeguard for Privileged Passwords Appliance is booted, DO NOT press and hold the Red X button for more than 13 seconds. This will hard power off the appliance and may result in damage.
- Down, up, left, and right arrow buttons: When the appliance is running, the LCD home screen displays: Safeguard for Privileged Passwords <version number>. Use the arrow buttons to scroll through the following details:
  - Serial: <appliance serial number>
  - X0: <appliance IP address>
  - MGMT: <management IP address>
  - MGMT MAC: <media access control address>
  - IPMI: <IP address for IPMI>

# **Product licensing**

7.0 require a new

**CAUTION:** All customers upgrading to Safeguard for Privileged Passwords 7.0 require a new license. For more information, contact Support.

#### **Hardware appliance**

The Safeguard for Privileged Passwords 3000 Appliance and 2000 Appliance ship with the Privileged Passwords module which requires a valid license to enable functionality.

You must install a valid license. Once the module is installed, Safeguard for Privileged Passwords shows a license state of **Licensed** and is operational. If the module license is not installed, you have limited functionality. That is, even though you will be able to configure access requests, if a Privileged Passwords module license is not installed, you will not be able to request a password release.

#### **Virtual appliance Microsoft Windows licensing**

You must license the virtual appliance with a Microsoft Windows license. We recommend using either the MAK or KMS method. Specific questions about licensing should be directed to your Sales Representative. The virtual appliance will not function unless the operating system is properly licensed.



#### Licensing setup and update

#### To enter licensing information when you first log in

The first time you log in as the Appliance Administrator, you are prompted to add a license. The **Success** dialog displays when the license is added.

On the virtual appliance, the license is added as part of Initial Setup.

IMPORTANT: After successfully adding a license, the Software Transaction Agreement will be displayed and must be read and accepted in order to use Safeguard for Privileged Passwords.

#### To configure reminders for license expiration

To avoid disruptions in the use of Safeguard for Privileged Passwords, the Appliance Administrator must configure the SMTP server, and define email templates for the License Expired and the License Expiring Soon event types. This ensures you will be notified of an approaching expiration date.

Users are instructed to contact their Appliance Administrator if they get an "appliance is unlicensed" notification.

As an Appliance Administrator, if you receive a "license expiring" notification, apply a new license.

#### To update the licensing file

Licensing update is only available using a virtual machine, not via the hardware.

#### To perform licensing activities

Go to the licensing page:

- 1. Navigate to Appliance | Licensing.
  - To upload a new license file, click +Upload new license file and browse to select the current license file. The Software Transaction Agreement will also be displayed during this process and must be read and accepted in order to complete the licensing process.
  - To remove the license file, select the license and click Remove selected license.



# **Update and installation instructions**

**CAUTION:** For customers upgrading to 7.0 from a previous Safeguard for Privileged Passwords release, be aware the following changes are required prior to upgrading:

- New license (https://support.oneidentity.com/contact-us/licensing).
   Once the new license is installed, Appliance Administrators will need to read and accept the Software Transaction Agreement before Safeguard for Privileged Passwords will be fully functional.
- Must apply the OS patch release prior to upgrading to 7.0. For more information, see One Identity Safeguard for Privileged Passwords required Operating System Patch Pre-requisite for SPP 7.0 LTS (338064).
- Approval Anywhere has been deprecated. Any Safeguard for Privileged Passwords customers also currently using Starling Two-Factor Authentication as their authentication provider should wait to upgrade until they have removed all Starling Two-Factor Authentication related user information.

The Safeguard for Privileged Passwords 3000 and 2000 Appliances are built specifically for use only with the Safeguard for Privileged Passwords privileged management software, which is pre-installed and ready for immediate use on the hardened appliances.

Safeguard for Privileged Passwords virtual appliances and cloud applications are also available.

# To set up a new deployment: 3000 Appliance, 2000 Appliance, Virtual Machine, or Cloud

If this is a new physical appliance, virtual machine, or cloud deployment, see the *Safeguard* for *Privileged Passwords Appliance Setup Guide*. The guide is also included in the package with a physical appliance.

# To update an existing physical appliance or virtual appliance with this patch

It is the responsibility of the Appliance Administrator to upgrade Safeguard for Privileged Passwords by installing an update file (patch). Consider the following:

- **Minimum patch version**: 6.0.0.12276. If you are running an earlier version of the Safeguard for Privileged Passwords Appliance, you must upgrade to this version before applying the 7.0 patch.
- **Clustered environment**: See the Patching cluster members section in the Safeguard for Privileged Passwords Administration Guide for instructions on how to deploy a patch so all appliances in the cluster are on the same version.



#### Prepare to install a patch

- 1. Backup your appliance before you install a patch. Once you install a patch, you cannot uninstall it. See the *Safeguard for Privileged Passwords Administration Guide*, Backup and restore topic.
- 2. Download the latest physical appliance patch or virtual appliance patch from the One Identity Support Portal:
  - https://support.oneidentity.com/one-identity-safeguard-for-privileged-passwords/download-new-releases

#### To install the hardware patch

- 1. As an Appliance Administrator, log in to the Safeguard for Privileged Passwords client.
- 2. Select Appliance Management | Appliance | Patch Updates.
  - The current appliance and client versions are displayed.
- 3. Click **Upload a File** and browse to select the update file you downloaded from the One Identity support web site.
  - NOTE: When you select a file, Safeguard for Privileged Passwords uploads it to the server, but does not install it.
- 4. Once the file has successfully uploaded, click **Install Now**.

#### To install the virtual machine patch

- Make adequate resources available. The virtual appliances default deploy does not provide adequate resources. The minimum resources required are: 4 CPUs, 10GB RAM, and a 500GB disk. Without adequate disk space, the patch will fail and you will need to expand disk space then re-upload the patch.
- 2. Go to the web management console and click **Setup** and follow the wizard.

# Verify successful installation

You can verify that the correct version has been successfully installed from the Safeguard for Privileged Passwords desktop client or the LCD on the Safeguard for Privileged Passwords Appliance.

#### To verify the uploaded patch was installed

- 1. Log in to the Safeguard for Privileged Passwords client as an Operations Administrator or an Appliance Administrator.
- 2. Select Appliance Management | Appliance | Appliance Information.
- 3. Verify the correct appliance version is displayed in the appliance properties pane.

In addition, when the appliance is running, the LCD home screen on the front panel of the appliance displays **Safeguard for Privileged Passwords** <version number>. Therefore, you can verify the correct appliance version is running from there, as well.
